**Navarro County Appraisal Review Board**  
**Meeting July 8, 2025** Should be July 10, 2025

The Appraisal Review Board of Navarro County met at 8:15a.m., July 10, 2025, at 1250 N. 45<sup>th</sup> St. Corsicana, TX 75110.

Mr. Kilgore called the meeting to order at 8:16 a.m.

Mr. Kilgore confirmed that the agenda was posted in accordance with Chapter 551, Texas Government Code, as amended, known as the Texas Open Meetings Act.
